

NOTE: The Membership Fee will not change if it is not paid by the due date but the member return credit will be forfeited.

- **4.** All memberships (excluding 6 month memberships) are due for renewal on July 1st each year. If you have any queries regarding membership, please contact 5251 3391.
- 5. GST: all membership categories are inclusive of GST and affiliation fees.
- 6. If a new member joins the Club after the commencement of the financial year, the member may be entitled to a reduced Annual Subscription for the first year of membership. In subsequent years, the member must pay the full Annual Subscription.

The Annual Subscription is due on the 1st July each year. Where a pro rata applies, the subscription fee portion of your total fee will be calculated on a pro-rata basis from your date of joining until the end of that financial year. Any other applicable fees/charges will be charged in full.

The Annual Subscription applicable to a new member is that due on the 1st day of the month of joining the club.

CLIFTON SPRINGS GOLF CLUB INC PRIVACY POLICY

Protecting your privacy has always been important to us. Changes to the Commonwealth Privacy Act now require us to handle your personal information in accordance with a set of principles, known as the National Privacy Principles (NPPs) in the Privacy Act 1988.

The following statement explains how we use and disclose information collected from you.

WHAT INFORMATION DO WE COLLECT FROM YOU?

Personal information is generally defined as information or an opinion that can identify a person. We ask you to provide personal information such as your name and address, date of birth and occupation and the collection of this information is to satisfy our legal requirements with Liquor Licensing Victoria.

HOW DO WE USE THE INFORMATION THAT WE COLLECT FROM YOU?

In general, our policy is that we only use or disclose personal information for the purpose which was either specified or reasonably apparent at the time we collected it. We may also use or disclose it for any other related purpose for which a Member, Club Employee or Customer would reasonably expect it to be used.

If the Clifton Springs Golf Club wishes to use or disclose personal information in other circumstances it will obtain the Member's, Club Employee's or Customer's consent to do so, other than in exceptional circumstances such as:

Where Clifton Springs Golf Club Inc reasonably believes it is necessary to protect any person and/or Clifton Springs Golf Club Inc rights or property: or

The use is authorised by law or is reasonably necessary to enforce the law.

SHARING OF INFORMATION WITH THIRD PARTIES

Clifton Springs Golf Club Inc will not sell Member's, Club Employee's or Customer's personal information to third parties. The only circumstances in which third parties may be given access to a Member's, Club Employee's or Customer's personal information are when contractors and service providers are helping operate our business or providing a service to our Members, Club Employees or Customers. In such events, we require third parties to agree and abide by our Privacy Policy and to observe strict conditions governing how this information may be used.

YOUR ACCESS TO INFORMATION WE COLLECT

Members, Club Employees and Customers may request personal information we hold about them.

SECURITY OF PERSONAL INFORMATION

Clifton Springs Golf Club Inc will take reasonable steps to protect personal information it collects and ensure it is accurate and up-to-date. All information is held on computer in controlled environments. Club Employees are required to maintain the confidentiality of any personal information held by the Clifton Springs Golf Club Inc.

MARKETING

Clifton Springs Golf Club Inc will only send advertising material to Members and Customers when:

- . They have indicated their consent to receive mail; or
- . Where the advertising mail is related to the purpose for which the information was collected; or
- . If it would be within an individual's reasonable expectations to receive such mail.

CHANGES IN THE FUTURE

Clifton Springs Golf Club Inc reserves the right to change its Privacy Policy at any time and will notify its Members, Club Employees and Customers accordingly.

GOLF LINK

"In regards to each member's personal information, Golf Australia requires the information for the purpose of GOLF Link. Your personal information will only be used in accordance with the GOLF Link "activity" and to provide you with GOLF Link services. If the requested information is not provided to Golf Australia you may not be able to obtain GOLF Link services including an official Australian handicap. Should you wish, you will be able to access your personal information through Golf Australia upon reasonable notice."

"The GOLF Link "activity" is defined in Golf Australia's agreement with the Club. This essentially covers the provision of a uniform handicapping system, the development of the support and the funding of it. By being listed on GOLF Link, Members are inviting Golf Australia to provide goods and services that support GOLF Link. Members not wishing to receive marketing material should advise Golf Australia in writing accordingly."





CLUB INFORMATION

Practice facilities

Clifton Springs Golf Club have 2 hitting nets, a practice putting and chipping green, a pitching area and practice fairway that is shared with the 10th fairway (only available during non-competition times).

Return Credit

Clifton Springs Golf Club has a \$100 Return Credit Policy for some membership categories (these are listed on the fees list). The \$100/\$50 is to be used in each financial year and cannot be accumulated for the following year. This House credit can be used in the clubhouse for food and drinks or in the Pro Shop.

Members Accounts - Terms and Conditions

Prize Account

All prize amounts on account as of 30th May will be deducted from the member's subscription renewal amount and an invoice issued for the reduced amount. Prizes won in June will be accredited to the following year's account or by arrangement with admin staff deducted from member's subscription renewal amount as per above. Should a member choose to not re-join, all prize amounts will have to be used by June 30th or forfeited. Life members will need to have their prize amounts used by June 30th or forfeited. Prize amounts can be used in all areas of the Club - Proshop, Bar, Bistro, Membership etc, and cannot be redeemed for cash.

Usable Advance Account

This is where the members return credit is held (\$100/\$50) and is forfeited if not used by 30th June. These amounts can be used in the Bar, Bistro and Proshop only and cannot be redeemed for cash.

E-Wallet Account

A maximum amount of \$200 is to be held in this account and cannot be forfeited. The maximum amount is set to protect the Club from potential money laundering issues. These amounts can be used in the Proshop, Bar, Bistro, Membership and cannot be redeemed for cash.

Note:- Money is not transferable between accounts of the member or to another member's account.
